

Thoughts from the Chair //

Since Bill Thickstun became Chair of the Oneida County Democratic Committee last year, I agreed to be Chair of the Kirkland Democratic Committee, just in time for the wild election and post-election months.

Kirkland continues its run of Democratic majorities in state and national elections; we still need to press forward with our work here, but also to spread our progressive values to the county and region. We are thrilled that energized, grassroots activist groups have emerged to partner with us in these efforts. The County Committee is also energized; Bill reports that



"we've appointed 88 new members to the county committee this year and held a successful fundraiser in April with NYS Comptroller Tom DiNapoli as our main speaker." Normally there would have been just a few new committee members in an off-year like this one.

The constant barrage of actions of the current administration in Washington, which endanger the health, welfare, and rights of the most vulnerable of our neighbors, may threaten to paralyze us, but we must continue to act. Turning the government around will be a long hard slog, but we are doing it the right way, starting at the local level and working up. The Kirkland Democratic Committee is full for the first time ever, but we can always use volunteers!

It is important to define our party not only as against the current administration, but in the promotion of our ideals and progressive values.* Never forget that **we**, not some consultants in DC, are the Democratic Party. // County Legislator Chad Davis, Oneida County District 14

Chad Davis, who represents the Village of Clinton and large portions of the Towns of Kirkland and New Hartford, will be running for re-election this fall. When asked about a piece of legislation that he was proud to be a part of recently, without hesitation he said: "It was the fast action taken by the County Board to provide \$2.75 million for flood relief efforts after the July 1, 2017 storm that severely impacted hundreds of families, homes and public infrastructure in Clinton,

Kirkland and New Hartford as well as many other towns and villages within the County of Oneida."

"Climate Change is real and it is happening in the here and now," said Davis. "Government funds have to be used prudently and preemptively to better guard against these re-occurring disastrous events." Davis explained that the County will use \$2 million for flood mitigation projects, \$500,000 for clean-up work and \$250,000 will be for homeowner assistance. While some State of New York assistance came to the Mohawk Valley, more is sought. Meanwhile, red tape and fact-gathering information - needed for FEMA aid - has prevented timely assistance from the federal government. Davis added, "Flood abatement projects at the County level of government will, inevitably and inexorably, be ongoing in light of the frequency of these terrible events."
